Sub : Regarding granting temporary affiliation of new Sahid Matangini Hazra Govt. Degree College for Women with effect from the session 2015-2016.

Dear Sir,

I have been directed to inform you that on receipt of the letters bearing No. 712-A/4c-12a/97(pt) dated 30.04.2015 received from the Director of Public Instruction, West Bengal, Education Directorate pertaining to introduction of UG Honours and Pass Courses in Sahid Matangini Hazra Govt. Degree College for Women in the district of Purba Medinipur and on the basis of the Inspection Report submitted by the duly constituted Inspection Team, the Seventh Executive Council of Vidyasagar University in its meeting dated 19.05.2015 & 26.06.2015 respectively has considered the inspection report regarding affiliation to the following Honours & General courses along with the intake capacity of New Sahid Matangini Hazra Govt. Degree College for Women which will run the course from the academic session 2015-2016 subject to fulfillment of the following terms & conditions :

- 1) Honours : Bengali - 25, English - 25, Sanskrit - 25, Philosophy - 25, Political Science - 25, Geography - 25, Economics - 25, Statistics - 15, Geology - 15.
- 2) General : Bengali - 40, English - 40, Sanskrit - 40, Philosophy - 40, Political Science - 40, Geography - 40, Economics - 40, Physics - 25, Chemistry - 25 & Mathematics - 25.

The terms & conditions of affiliation of the above courses :

01. The Governing Body of the College to be formed according to Vidyasagar University First Statutes, 1983 within one year from the date of affiliation.
02. Principal and Teachers in different subjects are to be appointed as per the Govt. norms.
03. Guest teachers/Part-time teachers may be appointed as per the requirement of the college authority.
04. Allotment of classes and payment of salaries to guest/part-time teachers to be made as per G.O. (Govt. of West Bengal).
05. Two sections may be made for each of the compulsory Bengali, English and Environmental Science classes, if required.
06. The college will be a normal day college.
07. The college must develop and maintain a play ground.
08. Separate Common Room will have to be provided for the Girls' students.
09. The college must abide by the Vidyasagar University Act, Statutes, Ordinance & Regulations etc.
10. The remaining portion of the College building will have to be completed within one year from the date of receipt of the affiliation.
11. The college will have to submit a compliance report to the University after fulfilling the above conditions on receipt of which formal affiliation will be extended.

An early reply accepting the terms and conditions of granting affiliation to the New Sahid Matangini Hazra Govt. Degree College for Women should reach within fifteen days from the date of issue of this letter to the undersigned with a copy to the Inspector of Colleges of this University.
